I represent that I am the parent or legal guardian of the participant(s) named below, or I have obtained permission from the parent/legal guardian of the participant(s) named below to execute this agreement on their behalf. I agree that the participant(s) named below and I shall comply with all stated and customary terms, posted safety signs, rules, and verbal instructions as conditions for participation in open bounce or any party event/program sponsored Bounce De Lis (BDL PARTIES, LLC). In addition, if I observe any hazard during our participation, I will bring it to the attention of the nearest Bounce De Lis employee or official immediately. I am aware there are inherent risks associated with participation in Bounce De Lis (BDL PARTIES, LLC) programs, parties, anti/or use of the bounce/play area and inflatable equipment and I, on behalf of myself and the participant(s) named below, knowingly, voluntarily and freely assume all such risk, both known and unknown, including those that may arise out of the negligence of other participants; and, I, for myself and the participant(s) named below, and our respective heirs, assigns, personal representatives, and next of kin, hereby release and hold harmless, Bounce De Lis (BDL PARTIES, LLC) their affiliates, officers, members, agents, employees, and other participants from and against any and all claims, injuries, liabilities or damages, including all associated attorney's fees for any of the parties, which are related to or arising out of our participation in any and all of Bounce De Lis (BDL PARTIES, LLC) programs, activities, parties, and the use of the bounce/play area and/or inflatable equipment or play toys/games.

Canned/aerosol spray strings (silly strings) in any form are strictly prohibited in or around the BDL PARTIES, LLC premises at any time. Canned/aerosol spray string creates vinyl and stitching damage to the inflatables and harsh chemicals must be used in order to remove canned spray strings and it's residue; which also degrades the vinyl integrity. You WILL incur a damage and cleaning fee to be determined by BDL management between a minimum of \$50.00 - \$500.00 or up to full replacement of the inflatable unit! Including any lost business incurred! Bounce De Lis is **A PLAY AT YOUR OWN RISK FACILITY**. As the Guardian for the children checked in with you, you agree that you are *all KNOWINGLY* playing at your own **RISKS! Socks are required to play!**
